- Staff changes explained.
- The teaching staff have had to transfer their thinking and practice to continue delivering education to students. Candi mentioned their efforts have been outstanding and is overwhelmed with their efforts. Parents have been great companions in the uptake of continuing the education their children.
- Attendance numbers in Term 2 have been strong for students of essential workers and limited resources at home. Week 1 began with 65 and peaked at 79 attending school. Wk2 averaged 79 students and Wk3 began with 85 students.
- Boarding numbers have been restricted by 1.5m social distance rule and use of facilities. New rule is 2 boarding students/toilet and shower. Week 1 had 9 boarders, Week 2 had 23 boarders in male and female campuses.
